THE DEAN DECLARES

Art. 1

We hereby announce the public selection, through competitive examinations, for admission to the a.y. 2018/19 (XXXIV cycle) **via Supernumerary, without scholarship, of n.1 candidate to “Molecular and translational oncology and innovative medical-surgical technologies” Ph. D. Course; Candidate may be admitted if he holds a scholarship or a research contract which is part of projects of international training in the framework of highly qualified international Calls.**

The enrollment of the PhD student in supernumerary is subject to the candidate holds an economic treatment at least equal to that provided by the doctoral scholarships provided by the University of Magna Græcia di Catanzaro for two years.

The PhD course "Molecular and Translational Oncology and Innovative Medical-Surgical Technologies" is divided into the following *Curricula*:

- Molecular oncology
- Biomedical, systems and applied nanotechnologies engineering
- Medical and translational oncology

- Innovative technologies and therapies in urological and gynecological surgery and fertility preservation.

Art. 2

Anybody holding a **scholarship or a research contract which is part of projects of international training in the framework of highly qualified international calls and possessing also a “laurea magistrale”** belonging to one of the degree classes listed below, that is a degree obtained under regulations prior to Italian D.M. 509/1999, approved with D.I. 9 July 2009, or any suitable foreign degree, may apply to take part in the selection process for admission **via Supernumerary** to Ph.D. "Molecular and Translational Oncology and Innovative Medical-Surgical Technologies", without age or citizenship limits:

Foreign qualification suitability will be established by the Ph.D. committee following the guidelines and current regulations in Italy and in the qualification issuing country, as well as of treaties or international agreements on qualification recognition for further study and will have to be confirmed by the Academic Senate.

In the case of a qualification obtained abroad, candidates must attach to their application any document which might be relevant to the assessment, translated and certified by the relevant Italian bodies in the country of origin, and following current regulations for the admission of foreign students to Italian University post-graduate programmes.

Art. 3

Candidates wishing to participate for n.1 Supernumerary PhD position must required to present in paper format the “Domanda” (Fac simile - attachment A to this announcement), duly completed and signed.

Applications must be delivered by hand, courier, PEC or by registered post with notification of receipt, **within and no later than the deadline of the present call for applications.**

In accordance with article 2 of D.P.R. n. 1077/70, the stamp and date of the post office will be proof of conveyance. In any case, and even where sent on time, applications which for whatever reason will arrive later than 7 (seven) days after the deadline will not be considered.

The application form and attachments, must be included in an envelope.

The envelope will have to clearly state the following:

The application must be sent exclusively by the personal certified user account; therefore, applications sent from simple / ordinary e-mail or sent by non-personal account will be excluded. The application for participation in the selection announcement to be submitted using the facsimile attached to this announcement must be signed and scanned in PDF format with the attachments. A compressed folder (zip files no larger than 40 megabytes) must also be attached, which must contain all the documentation that the candidate intends to submit for evaluation by the Commission. The certified e-mail does not allow attachments that have a size equal to or greater than 40 megabytes. The candidate who has to send attachments that overall exceed this limit, must send an e-mail with the request stating that the attachments, or part of them, will be transmitted with a further e-mail together with the previous one already sent.

No complaints are accepted for late applications. Applications sent by priority post will not be accepted.

Application delivery is at the exclusive risk of the sender, should the application, for whatever reason, not get to destination in time.

Should the deadline fall on a public holiday, it will be extended to the next closest working day.

Applications for participation will be excluded from the selection:

- applications not sent in the manner prescribed by this article;
- applications sent by certified e-mail not by a user the candidate's personal e-mail;
- applications are sent or delivered after the deadline established by the present call for applications or, even if sent on time, are delivered to the University later than 7 (seven) days from the deadline.

The exclusion from the selection for the aforementioned reasons will be notified to the candidates exclusively by notice on the University website at <http://web.unicz.it/it/page/dottorati-di-ricerca> , normally within on the fifteenth day following the expiry date of this announcement. The University will provide no other form of notification.

Inside the above-mentioned envelope must be included:

- 1) “Domanda (application, attachment A)”
- 2) *curriculum vitae et studiorum*
- 3) *research project carried out* which is part of projects of international training in the framework of highly qualified international Calls
- 4) documentation proving the ownership of the scholarship or research contract which is part of projects of international training in the framework of highly qualified international Calls

- 5) In the case of a qualification obtained abroad, (attachment B) application for recognition of a foreign qualification to be completed on the facsimile (attachment B)
- 6) a copy of a valid piece of ID.

Candidates will be expected to give proof of Public Administration-issued qualifications by means of a declaration in lieu of certification (or self-certification) as set out by art. 46 of D.P.R.445/2000 and subsequent amendments. **All self-certifications must contain the date and authentic signature.**

The same procedures should also be followed by:

- EU citizens,
- citizens of non-EU states who are settled in Italy, limited to the verifiability of status, personal qualities and achievements from Italian public bodies (for example, if they obtained a degree from an Italian University).

Non EU candidates who have studied abroad must attach the original certificates and their relative translations . Such candidates will be admitted to selection conditionally, and will be excluded from the Ph.D. programme should it emerge, upon verification, that the title held does not correspond to the requisites listed by the present call for applications and therefore does not allow for enrolment in the Ph.D. programme.

Candidates must attach the adequate declaration in lieu of affidavit, in accordance with art. 47 of D.P.R. 445/2000 and subsequent amendments, in which they certify compliance to the original of the publications presented. Further, candidates must declare under their own responsibility and in accordance with D.P.R. n. 445/2000 the truthfulness of the data and information in the *curriculum vitae et studiorum*.

It is necessary to specify, for all qualifications and all information included in the *curriculum vitae et studiorum*, all elements which may aid the process of verification by the Administration (e.g. *Start/end date, institution/company, duration of grant/contract, marks, position filled, etc.*)

Applications for participation will be excluded from the selection:

- a. candidates without admission **requirements**;
- b. do not bear the original signature of the candidate;
- c. do not contain photocopy of a valid piece of ID.

All candidates are admitted to selection upon condition of verification that they fulfil the requisites set out by the call for applications.

The University may, at any time during the process and following the start of the Ph.D. programme, carry out checks on the truthfulness of the information provided, in accordance with law DPR n. 445/2000 and its subsequent amendments.

Should motives for exclusion be determined after the start of the programme, the University may arrange, through a provision justified by the Dean, for the exclusion of the candidate from the selection process or the Ph.D. programme and the revoking of any related benefits, with no prejudice to the penal responsibilities for falsification of documents and false/untrue/fraudulent statement as set out in art. 76 DPR 445/2000, as may apply.

Art. 4

The Judging Committee is appointed with an ordinance issued by the Dean upon consultation with the Teaching Body.

In the first meeting the Judging Committee will first determine the criteria for evaluating the applications.

The criteria will be published, on the website of the University at <http://web.unicz.it/it/page/dottorati-di-ricerca>.

Art. 5

Admission to the Ph.D. programme will be granted on the basis of a selection process

The selection process consists of evaluation of research project and an interview.

Interviews will be conducted in a classroom open to the public.

The interviews can also take place via Skype or videoconference

The Judging Committee will evaluate the coherence between the research project, already selected by a qualified Commission, and the interdisciplinary areas of interest of the PhD Programme and will evaluate the correspondence of the research project in the most consistent doctoral curriculum.

Maximum 30 points are assigned to the evaluation of the research project with particular reference to the appropriateness according to the interdisciplinary areas of the research doctorate.

Maximum of 30 points are assigned to the interview. The evaluation of the research project and the interview are considered passed with a score of at least 21/30 for each test.

In order to be considered suitable, candidates will have to have a score of no less than 42/60.

Exam date, time, place and any other useful information for interview will be made known only by publication of a notice, by the expiry date of this notice on the University website, at <http://web.unicz.it/it/page/dottorati-di-ricerca> .

After completing the interview, the **Judging Committee**, based on the predetermined criteria, will form the ranking based on the scores obtained by the candidates; the ranking will be published on the website of the University at <http://web.unicz.it/it/page/dottorati-di-ricerca> .

Art. 6

The first candidate in the ranking must enroll to first year with the procedures and within the deadline that will be assigned only by e-mail to the e-mail address indicated in the application form as the address chosen for the selection.

Successful candidate must pay, with the procedures and within the deadline that will be assigned only by e-mail, tuition fees and attendance at the PhD courses that are determined for a.y. 2018/2019, in the amount of € 1.124,45 plus “Tassa regionale per il Diritto allo studio” to be paid in three installments according to the following table:

In the event of non-coincidence between the period covered by the scholarship or the research contract for international training programs and the three-year duration of the Phd Course, the University of Catanzaro will provide the student with the scholarship of € 15.343,28 (yearly amount of the scholarship before taxes) for any remaining training period of the PhD **student up to a maximum of 12 months.**
