NOTICE FOR ADMITTED CANDIDATES

Please note that on 11.10.2022 will be published the Rector's Decree approving the selection documents for admission to the PhD course in Translational Research and Innovative Technologies Applied to Nutrition and Predictive and Precision Medicine, a.a. 2022/23.

Therefore, starting from 12.10.2022 it will be possible for candidates admitted to the aforementioned PhD course to enrol online in the manner indicated in art. 8 of the selection notice.

Candidates, after printing the application for registration in the first year, are required to declare, pursuant to and for the purposes of art. 46 and 47 of the DPR 28 December 2000 n. 445 and s.m.i., the possible simultaneous registration to another university course of study (point d) and the possible simultaneous performance of work (point h) by filling in the aforementioned sections (points d and h). The application shall be made by writing at the end of the application with an asterisk if the space is not sufficient to provide all the information.

At the time of registration, admitted candidates must:

- 1) Indicate the order of priority of the projects of interest by filling in the form available at https://web.unicz.it/it/category/bandi-ateneo. Admitted PhD students are required to select all projects funded or co-financed by the PNRR. In any case, it is strongly recommended to select in addition to all PNRR projects also all projects with a University/No Scholarship;
- 2) For the purposes of the award of any scholarship, admitted applicants are required to complete and attach to the registration application the presumptive declaration of gross total personal income available on the https website://web.unicz.it/it/category/bandi-ateneo;
- 3) Together with the enrolment application all admitted candidates must attach, also, the application for participation in the selection (printed exclusively from the online filling in procedure) signed in original accompanied by a copy of a valid identity document;
- 4) Please note that the first instalment of the tuition and attendance fees of the first year is for all admitted candidates of € 526.00 (euro cinquecentoventisei/00), resulting from the sum of the registration fee and attendance of the PhD course i rata I year of € 360,00, the fee for the right to study PhD of € 150,00 and the virtual stamp of € 16,00.
 - The admitted candidates who will result, with subsequent decree winners without scholarship, will be entitled to a refund of the fees paid with the exception of the fee for the right to the PhD study of \in 150.00 and the virtual stamp of \in 16.00;
- 5) Please note that the declaration of commitment containing the obligations arising from the implementation of the DD.MM. n. 351 and No. 352 of 9.04.2022,

available on the website https://web.unicz.it/it/category/bandi-ateneo (to be completed only by PNRR grant recipients) must be transmitted by PEC (or handover) with the same modalities indicated by the notice for the sending of the application, only after receiving communication from the Offices of the successful assignment of the PNRR grant, based on the preferences expressed by the winners.

The declaration must be transmitted without delay within the next 2 days from the communication by the offices.

The communication will be transmitted to the winners by e-mail or PEC, (if used for the admission competition);

6) attach: photocopy of a valid identification document, photocopy of the tax code, receipt of registration fees.
